Item I give and bequeath unto my Dear Sister now in England Mary Wrotten of her heirs Ten pounds Sterling as a Token of my Love

Item I give and bequeath unto my Dear Ancesters Mother if alive Ten pounds Sterling as a Token of my Duty and Last Love

Item I give and bequeath unto my friend & old acquaintance Roger Mathews Twenty Shillings to buy him a Ring as a Token of my Love & respects to him

Item as to all the rest of my Estate both Real and personal which I have by any means or ways any Right or Title unto after my just Debts & Legacies above mentioned are paid I do hereby Give and devise unto my Dear wife Anne Dale to her & her heirs & assigns for Ever & I do also hereby appoint and Ordain her my Dear wife my whole & Sole
